This Solicitation Amendment 003 is raised to incorporate responses to additional questions received.

Q1.) How many tonnes of Non-Contaminated Quality Soil should the contractor assume will require removal?

A1.) 0 tonnes.

Q2.) How many tonnes of asphalt should the contractor assume will require removal?

A2.) The existing asphalt is 2-3" thick, the specs are written assuming that this volume of material will be included in the contaminated soil disposal. If conditions/disposal or recycling options are different once the work on site starts, a discussion can be held at that time to permit the new disposal options at the discretion of the departmental representative.

Q3.) How many square meters and what thickness of asphalt should the contractor assume will require reinstatement?

A3.) 2" thick, twice. 4" in total.

Q4.) Section 01 52 00 1.10.1 stipulates the contractor is to provide onsite security personnel after working hours. Since the site is fenced and already security controlled is onsite security personnel still required?

A4.) Onsite security personnel will not be required.

Q5.) Table 11 Leachate Analytical Results BH17-02C shows leachable lead was detected. Is this still characterized as waste quality soil? Who will certify characterization of soil quality?

A5.) Please refer to A3.) of Solicitation Amendment 002.

Q6.) Does PWGSC have any pre-existing agreements with DND or any other 3rd party which would incur costs to PWGSC as it relates to Clause GC5.10 Assessments and Damages for Late Completion of the Contract documents?

A6.) Regardless of any pre-existing agreements, Clause GC5.10 remains in effect.

All other terms and conditions remain unchanged.
