1. **ANNEX C INUIT BENEFITS PLAN (IBP), Part A, paragraph Contractor Selection**, is to be deleted in its entirety and replaced by:

**Contractor Selection**

The Contractor selection will be based on the highest responsive combined rating of IBP and price. The ratio will be 10% Inuit Benefits Plan and 90% for the price.

IBP Score = (Bidder Points / Maximum Points) x 10

Cost Score = (Lowest Bid / Bidder Price) x 90
