Questions and Answers

Q1- You state that you would like Certifications for Welders, but no welders are required for this project. Is this an "As & When" requirement?

A1- Welding may possibly be required during a repair done by Task Authorization. In that case, we would require Contractor to submit welder qualifications with the price proposal.

Q2- Typically, Kohler equipment does not have an OEM/Firmware system that is proprietary. Will PWGSC confirm that our submission will be accepted with the understanding that the company is a manufacturer of engines, generators, and emergency electrical components and as such, is compliant owing to our professional standards and experience?

A2 If you can submit a document from Kohler indicating that their firmware system is non-proprietary, then yes.

Q3- When is the Quinquennial scheduled? Normally the Quinquennial takes place in the 3rd year of the contract. As this is a 3 Year + 3 option Year contract, please state when you would like this service application to take place.

A3- In the second year; this gives us time to effect repairs if needs be.

Q4- Please confirm the Monthly Inspections with include Generator and Fuel Technicians.

A4- Scope of monthly tests is described in Table 3 of the SOW. No fuel system checks are required beyond what is specified in CSA C282-15, OEM Manual, and local codes.
