### **De-icing Compound**

This amendment is raised to answer questions:

**Question:** Under 2.1 Contractor with access to the salt domes delivery areas at all times:

What kind of unloading dock do you have? For example does an international standard off loading dock that allows truck to directly offload product or should we send a flatbed truck with product in 1 ton bags that can be lifted off with a forklift to be stored somewhere?

**Answer:**

RP Ops presently does not have any unloading dock.

Our expectation is for the supply and volume delivery of the treated salt usually by means of a tractor trailer with "live bottom" capability.

One (1) ton bags does not meet our requirement.
