DEPLOYABLE CT SCANNER

This amendment was raised to provide Canada's answers to Offeror's and to amend ANNEX A – Section 4 Standards and Specifications for the Request for Proposal:

Questions:

1. This Question is with regards to Section 4 Standards and Specification standard “e”

The CT Scanner Container must have all doors and openings sealed against the ingress of dust in accordance with DEF STAN 07-55 Part 2 Section 4/1 Test D1

It appears that this standard was original in acted in 1975 is currently no longer active and has been superseded by DEF Stan 00--35 :Chapter 3-27 can you please confirm which standard the container must meet for dust ingress.

Answer:

In order to align the requirement with the most applicable standard, and in an effort to more clearly define the requirement, the following modifications are being made under Annex A – Section 4 – Standards and Specifications:

DELETE:

ANNEX A – Section 4 – Standards and Specifications Para “d”

INSERT:

(d) As a minimum, the CT Scanner Container must be protected against water ingress in accordance with DEF-STAN 00-35 Part 3 / Issue 4 – Chapter 3-27 – Test CL27 – Driving Rain.

DELETE:

ANNEX A – Section 4 – Standards and Specifications Para “e”

INSERT:

(e) As a minimum, the CT Scanner Container must have all doors and openings sealed against the ingress of airborne particles of fine matter in accordance with DEF-STAN 00-35 Part 3 / Issue 4 – Chapter 3-25 – Test CL25 – Wind Blown Dust and Sand.

2. Our question is about certificates that are not issued until partway or at completion of the build of the system, but you ask for certificates to be included with the bid in a number of the Mandatory Technical Criteria at Annex C as shown below:

Please confirm that it will be acceptable not to provide the certificates shown with our bid for the reasons shown above but note that they will be provided after manufacture is complete.

Answer:

Given certifications cannot be provided prior to construction, MS3, MS5, MS6 and MS16 will be removed from the evaluation criteria. All other mandatories remain in force.
Instruction to Bidders - Bidders are required to meet these mandatory certifications at point of delivery as a deliverable within Annex A, section Q.

All other terms and conditions of this Request for Proposal remain unchanged.
