AMENDMENT 001

The Solicitation Amendment 001 is raised in regards to the following:

1. The closing date of March 27, 2019 is postponed to April 10, 2019.
2. To provide the answers to the bidders questions.

Question 1:

We are wondering if this FR jacket has gone out to tender before, and if so, can you tell us when, who was the contract awarded too and the value of the award?

Answer 1:

This is the first time that this requirement is out for tender.

Question 2:

From reading the tender documents, viewing a sample jacket, and seeing the material patterns, only comes after the award closes and a request is made by the RCMP to a vender to make a pre-award sample. As you can appreciate, not being able to touch and see the sample Jacket and not being able to see the patterns, makes it impossible to produce a competitive bid. The line drawings provided with in the tender documents is not enough information, it does not show all the individual cut pieces not does it show the individual bits and pieces that make up the jacket. A sample allows us to see all the bits and pieces that make up the jacket and how all those pieces come together and seeing the patterns allows us to figure out how to lay out the patterns on the material, in order to know how much material each jacket needs. Unless a sample Jacket can be made available for viewing or the patterns be sent out for viewing, we cannot proceed with a bid. The tight timeline to place a bid is an issue. With just over two weeks remaining, is not sufficient time to figure out all the details needed in order to place a competitive bid. We request a minimum of 4 weeks extension and fi the jacket cannot be viewed, than we also request someone at the RCMP produce detailed/sharp digital images of the jacket at as many angles as possible and close-up detailed images of all the individual bits and pieces that make up this jacket".

Answer 2:

This is a new item, therefore there are no viewing samples available at this time. The specification must govern. The scale of measurements can be used to estimate yield. No further extensions will be given.

Question 3:

Is PWGSC aware of any suppliers we can contact for the mesh fabric described in section 4.1.3 of G.S. 1045-370?

Answer 3:

It is the responsibility of the manufacturer to source materials which meet the requirements outlined in the specification.

All other terms and conditions remain the same.
