<b>Question 18</b>	Regarding the subject solicitation could you please confirm that turbine powered UAV is also accepted instead of battery powered UAV?
<b>Answer 18</b>	<p>Due to the locations and conditions of use, the UAS must be battery powered.</p> <p>Per the System Performance Specification (SPS), paragraph 2.1, System Maturity:</p> <p>The current version of the Ground Control System (GCS) and the current version of the aircraft (i.e. propulsion system, avionics and structural components) of the System must be a COTS product with demonstrated flight history. A newer revision of the System based on an operational system configuration will be considered acceptable.</p>
<b>Question 19</b>	Since this information may change our potential design, we kindly request two weeks extension to the deadline.
<b>Answer 19</b>	The closing date remains the same.
