This amendment No. 004 is being raised to make the following changes to solicitation W0142-18X021/A:

Changes apply to the rebid periods only.

1) Part 1, Section 1.2 Summary:

Delete: 1.2.3 - The requirement is subject to a preference for Canadian goods and/or services.

2) Part 4, Section 4.1 Evaluation Procedures:

Delete:

(c) The evaluation team will determine first if there are two or more offers with a valid Canadian Content certification. In that event, the evaluation process will be limited to the offers with the certification; otherwise, all offers will be evaluated. If some of the offers with a valid certification are declared non-responsive, or are withdrawn, and less than two responsive offers with a valid certification remain, the evaluation will continue among those offers with a valid certification. If all offers with a valid certification are subsequently declared non-responsive, or are withdrawn, then all the other offers received will be evaluated.

3) Part 5, Section 5.1.2 Additional Certifications Required with the Offer:

Delete: Section 5.1.2.1 Canadian Content Certification - in its entirety.

4) Part 6 (A), Section 6.4.1 Period of the Standing Offer:

The period for making call-ups against the Standing Offer is from May 1, 2018 to April 30, 2019 plus two additional one year rebid periods. There will be one (1) rebid period at the end of the initial standing offer period of May 1, 2018 to April 30, 2019 and one (1) rebid period at the end of year two, May 1, 2019 to April 30, 2020.

6) Annex "B" Basis of Payment
