This amendment is being raised to modify the specifications and to answer questions for solicitation 5P201-18-0237/A:

1. MODIFICATION TO SPECIFICATIONS

DELETE:

Section 00 11 00 - SUMMARY OF WORK, Part 1.2.2.1.1.2.1

The heritage houses shall be abated using a peel-away lead paint removal system (application of an "ecofriendly" chemical gel/paste). Refer to the Statement of Cultural Resource Impact Analysis.

REPLACE WITH:

Section 00 11 00 - SUMMARY OF WORK, Part 1.2.2.1.1.2.1

Fifty percent (50%) of the exterior wooden cladding of the Baseball Office is weathered and must be removed and replaced in kind with new unpainted wood. The remainder of the exterior wooden cladding shall be abated using a peel-away lead paint removal system (application of an "ecofriendly" chemical gel/paste). Refer to the Statement of Cultural Resource Impact Analysis.

Ten percent (10%) of the exterior wooden cladding of the Owners House is weathered and must be removed and replaced in kind with new unpainted wood. The remainder of the exterior wooden cladding shall be abated using a peel-away lead paint removal system (application of an "ecofriendly" chemical gel/paste). Refer to the Statement of Cultural Resource Impact Analysis.

Ten percent (10%) of the exterior wooden cladding of the Program Office is weathered and must be removed and replaced in kind with new unpainted wood. The remainder of the exterior wooden cladding shall be abated by removal of LBP, enclosure or encapsulation.

CLARIFICATION:

Repainting is not mentioned and is not required by the contractor.
