<b>Question 1</b>	A supplier has provided the following question:  “We have provided many trailers like the one requested and there was a maximum height required over the wheels, is the same height still required in this tender?”
<b>Answer 1</b>	NOTE: This question was referred to the Technical Authority who rewrote the question in a more generic format so that other companies can understand what this requirement is talking about when posted on B&S and to provide an appropriate answer in response.  Q1: In a previous Request for Proposal for similar trailers (W8476-144846/001), there was a maximum height required over the rear wheels. Is the same height required for this tender?  A1: No. There is no specified maximum height over the rear wheels. Industry standard practice is expected.
