QUESTIONS AND ANSWERS

Question 27:

Regarding Table 2 –Providing client contact information for projects referenced up to 10 years ago is difficult as references change positions, move or retire. Would Canada consider it reasonable to only provide reference contact information for experience cited in the last 5 years?

Answer 27:

No, the requirement remains unchanged.

Question 28:

Regarding Table 2 - Please confirm that selecting "No" to question 4 ("Project was for a Government of Canada departments or large organizations with more than 1000 employees") has no impact on compliancy of a resource; except for where "Project was for a Government of Canada departments or large organizations with more than 1000 employees" is clearly requested in the matrix?

Answer 28:

Question 4 of Table 2 only applies for Business Continuity/Disaster Recovery Specialist – Level 3 - Mandatory criteria M1 and M2 and IT Security Methodology, Policy and Procurement Analyst – level 3 – Point rated criteria R1 and R3.

Question 29:

Amendment Reference: Amendment 003 - M1 and R1

Would the Crown reconsider modifying the **M1 corporate mandatory requirement** in the following ways?

1. Contracts claimed must have multiple resources and include a minimum of 2 of the required resource categories (with a combined minimum coverage of 4 resource categories across all contracts used to demonstrate billable days); or
2. Notwithstanding the minimum days for TRA, further reduce the minimum billable days for the roles to be filled by single resource only to 80 days so the combined total for the three contractors would, at a minimum, equate to LOE for 1 FT resource.

Answer 29:

Canada has reviewed the request, however the requirement remains unchanged.
