Part 1 - Question/Answer:

Question #1:

What is the estimated budget for this tender?

Response #1:

The onus is on bidders to develop their pricing strategy based on the information provided in the ITT. The budget is not relevant to the bidding process.

Question #2:

On the drawings it has translucent laminated glass. Does that area require blinds?

Please clarify as to whether the entire window area needs to be covered. The blinds would have to be divided in the width as they would be too wide for one blind.

Answer #2:

Answer: Refer to Specification Section 12 49 00 for schedule of window types requiring roller shades. Areas of translucent glazing shown on the Window Type Schedule must be fully covered by specified roller shades. Width and height ranges for single shades are specified and must be available from the proposed manufacturer.

As per Section 12 49 00, Police Building Room 113 is scheduled to have 8 shades, meaning that shades are to be divided at vertical mullions of large-span windows Type D and E. Roller shades at Rooms 104, 106 and 126 are intended to be a single wide shade as scheduled.
