2.7 Optional Supplier's conference

1- A Supplier's conference will be held by WEBEX on 2019-04-15. The conference will begin at 12:45 pm EDT. The scope of the requirement outlined in the request for the Supply Arrangement will be reviewed during the conference and questions will be answered.

2- It is recommended that suppliers who intend to submit an arrangement attend this conference.

3- Suppliers are requested to communicate with the Contracting Authority before the conference to confirm attendance. Suppliers should provide, in writing, to the Contracting Authority, the name(s) of the person(s) who will be attending and a list of issues they wish to table no later than 2019-04-10 at 03:00 pm EST.

4- Suppliers can join the conference via the Government of Canada Teleconference Service - Webex. Participants joining by means of Webex will be able to view the presentation material on their computer as well as listen to the presenters in English through their telephone line. Suppliers are requested to register with the Contracting Authority before the conference to confirm attendance via Webex. The individuals named by the Suppliers will receive an email invitation by the Contracting Authority, which will include a link and a password to access the conference as well as the teleconference numbers. All Webex participants will be required to transcribe any and all of their questions through the chat feature to allow PWGSC to monitor and batch similar questions to be addressed during Question Period, following the presentation.

5- Suppliers are requested to specify in their list of participants, the type of assistance PWGSC should provide to accommodate persons with visual, hearing or any other disabilities.

6- Any clarifications or changes to the request for the Supply Arrangement resulting from the suppliers' conference will be included as an amendment to the request for Supply Arrangement.

7- Suppliers who do not attend will not be precluded from submitting an arrangement.
