Questions and answers:

Question 1 Could you please specify the information in addendum no. 1 in relation to the duration of the contract, because it is mentioned:

"The duration of the contract is two years from the date of contract award, with the option of extending the terms of the contract up to two additional one-year periods (1) under the same conditions. The Summary and Annex B "Basis of Payment" will be modified to reflect this information. The tenderers will complete the basis of payment with their total daily allowance."

Answer 1 **We have made the correction, please see RFP amendment below;**

The period of the contract is for one year from the date of contract award with the option to extend the terms of the contract by up to three additional one-year (1) periods under the same condition. The Summary and Annex B "Basis of Payment" will be amended to reflect this information. Bidders will complete the Basis of Payments with their total per diem.

Answer 2 As indicated in section 4.3; *"A bid must comply with the requirements of the bid solicitation and meet all mandatory technical evaluation criteria to be declared responsive. The responsive bid with the lowest evaluated price will be recommended for award of a contract."* Therefore for the total value of the contract including additional periods of 1 year

The Contractor agrees to remit to Canada Revenue Agency (CRA) any amounts of HST/GST/QST paid or due.

(c) All deliverables are F.O.B. Destination, and Canadian Customs Duty included, where applicable.

(d) The Crown will not accept any travel and living expenses incurred by the Contractor as a consequence of any relocation required to satisfy the terms of the Contract.

All estimates contained in the Contract relating to travel, optional items or as-and-when-requested goods or services are included solely for the administrative purposes of Canada and do not represent a commitment on the part of Canada to exercise such options or purchase such services.
