B) MINUTES

- Two points were brought up to start meeting:
 - In-stream work must be completed between June 1 and August 31, 2019
 - A fish passage assessment must be completed once the construction is completed to assess fish connectivity from the TCH culvert up to just past the removed weir site. Check the specifications for requirements
- The pictures of the site were reviewed and will be included with these minutes.
- The only construction in the Rogers Pass area that may affect this work is the new Washroom being constructed on the old service station/hotel site. There should be minimal impact to this project.
- Distance to weir site from water plant is approximately 500 m. The area around the water plant may be used as a laydown area. Approximate size of area around the water plant is around 500 m². Another laydown area will be provided at the old hotel site to accommodate riprap and other materials. There is only limited available area around the worksite to store materials and it is recommended to keep all materials at the lower laydown areas identified.
- There is no connection between the passive water system and the water plant. The passive water system is only used for highway work. The contractor will be asked to keep the disruption to this system as short as possible. While this system is being modified, the users of this system will be directed by PCA to an alternative source.
- The micro hydro system that used to be in the creek has been decommissioned and is no longer in service.
- The specs identify some BMPs in the reference documents. However, all the mitigation requirements in these documents have been included in the specifications. These documents will be given to the successful bidder after award for review
- A question was asked about what to do with surplus materials that may be generated from the channel work. Any material that can be used to backfill the tank and inlet structures should be used for that purpose. Any remaining material that cannot be used for construction is to be disposed of outside the park in an approved disposal site.
