QUESTIONS AND ANSWERS

Question 20: I found conflicting information between the last target images posted on Buy and Sell and the specs in the contract under Technical Requirement.

The attached files on Buy and Sell show

Tan: PMS 155 Green: PMS 362 Blue: PMS 300

However the Technical requirement in the contract shows

Tan: PMS 156 Green: PMS 354 Blue: PMS 3005

We have printed our samples based on the technical requirement in the contract and not the attached documents. If we are successful in winning the RFSO we can use either color; but I just want to make sure that our samples will be accepted based on the technical requirement information.

Answer 20: The correct colours are those on the files attached to Buy and Sell with amendment 004. Samples produced with either colours will be evaluated.

The vendor awarded the standing must produce the targets with the correct colours, as per the amended specifications.

As a result of this question, the solicitation document has been amended as follows:

4.1.1.1 Mandatory Technical Criteria

Pre-Award Samples

As part of the technical evaluation, to confirm an Offeror's capability of meeting the technical requirements, one (1) pre-award sample of each target (one blue and one green) must be included with the offer.

The Offeror must ensure that the required pre-award samples are manufactured in accordance with the technical requirement and is fully representative of the bid submitted. The pre-award samples will be evaluated for quality and conformance to specified materials and measurements. The sample submitted by the Offeror will remain the property of Canada.



Should the pre-award samples be rejected, the Offeror will be provided an opportunity to re-submit a second set of samples within two (2) weeks. Rejection of the second set of samples will result in the bid being declared non-responsive.

The Offeror must deliver the required pre-award samples at no charge to Canada and must ensure that they are received with the offer at the time and place of the Request for Standing Offer closing. Failure to submit the pre-award samples will result in the offer being declared non-responsive.

The samples should be submitted either flat, or rolled. They cannot be folded.
