Answer 10

The brief description is limited to one page and must include an overview of the bidder's contract, the resource categories provided and key responsibilities. It does not include the client particulars such as client name and title nor the reference signed letter.

Question 11

Please refer to Attachment 4.1 Bid Evaluation Criteria, 1.1 Mandatory Corporate Requirements, M.2 – Corporate Capability on page 129 of the RFP. Could the Crown please confirm that in order to qualify for the Level 2 category the referenced contract position must have required greater than 5 years of relevant experience in the specified category?
