The Request for Proposal (RFP) Amendment 003 includes answers to questions received from potential Bidders and an amendment.

QUESTIONS AND ANSWERS

Q18 - Due to the extensive response requirements, particularly in support of M1 for all five (5) resource categories, where bidders are required to support a substantial number of SOW tasks for each resource (for example: the IM Architect requires 17 of 22 SOW tasks supported), along with the fact that it is the time of year that many resources are away on vacation, we respectfully request a two (2) week extension to the closing date.

A18 - The RFP closing date has been extended until April 15, 2019. See amendment below.

Q19 - Given the number of large and complex Federal RFPs released recently, in addition to the difficulty in gathering content from external sources (specifically signed client reference letters and information required to qualify resources resource) during fiscal year end for many enterprises, in addition to the changes made to resource criteria, we respectfully request that the Crown provide an additional 2 week extension to allow vendors to properly gather and vet resource and reference content from external sources.
