**1. Bidders' Questions and Answers Set :**

**Question #1:**

We are experiencing difficulty in obtaining price/delivery information from a component manufacturer, Amphenol, for connectors needed for this requirement. It appears that the manufacturer may not be responding to their distributor's requests.

Parts involved are:

62ZN-56TG18-02SN Plug, 26482 Style, 2 Socket, ZnNi

62ZN-57T18-02PN Rcpt, Jam Nut, 26482 Style, 2 Pin, ZnNi

In light of this, the distributor recommends a commercial off-the-shelf replacement, 62GB prefix, which has same fit and function.

Will Canada accept the 62GB range, which has the standard green zinc finish (RoHS) instead of a black zinc-nickel finish of the 62ZN?

Can a further extension to the bid closing date be provided to accommodate a solution from the Technical Authority?

**Answer #1:**

The Technical Authority has verified that the above-listed "62ZN" parts do exist and are available from Amphenol. The alternate parts proposed in Question #1 would not be acceptable for this requirement. Unfortunately, given that two bid closing period extensions have been granted, no further extension can be granted.
