#### **Question 8:**

In MTC1 in each category stream you require the contractor to demonstrate experience, do the contracts identified by the contractor to show their experience have to be federal government contracts or would you except private sector contracts? Government experience but from a non federal government department? experience outside of Canada?

#### **Answer 8:**

Reference contracts from the federal government, from other levels of government such as provincial and municipal, from outside Canada, and from the private sector are acceptable as long as they meet all the criteria of MTC1.

#### **Question 9:**

It is our experience that many government contract, especially for IT services and or Cyber security are short term contracts for 1 or 2 resources. Would you consider the following in order to allow more companies to qualify for this RFP

- Would you consider changing the min project length from 1 year to 6 months?
- Would you consider changing the min project value from \$1000000 and \$2000000 to \$ 500000 in order to allow smaller companies to qualify?
- Would you consider changing the min cumulative total billable days from 2000 days to 750 day which would be the amount one resource working full time for 3 years would be able to bill. As many IT contracts are for single resources.
