AMENDMENT 003 TO OUR SOLLICITATION

QUESTIONS / ANSWERS

Question 1

Are there parking spaces for the contractor's employees who would want to get directly onsite in the morning?

Answer 1

Yes. Three (3) parking passes for Stationnement Montcalm will be supplied free of charge to the contractor for his employee's needs during the landscape maintenance contract period.

The parking passes will only be valid during the works period, Monday to Friday from 6:00 to 18:00.

Here is the address of Stationnement Montcalm : 701 Grande Allée West, west of the Battlefields park, accessible via Montcalm avenue.

Question 2

Is there a designated spot to park the tractor-trailer following the unloading of the mowing equipment? Or should it stay on the side of the road?

Answer 2

Parking on the side of the road will be allowed in order for the contractor to load, unload his equipment and for temporary parking of its vehicles during the works. It must be done safely (surroundings allowing visibility, traffic cones and/or appropriate temporary signs). Parking spaces equipped with parking meters cannot be used by the contractor without paying the related fees. Trucks and trailers must not obstruct visitors access and must allow free flow of safety and maintenance vehicles.

Can you tell me if the proposal requires a bid bond?
