## **AMENDMENT NO. 006**

This amendment is raised to answer bidders' questions.

### **QUESTIONS AND ANSWERS**

**Question 16:**

MTC1 requires contracts cited to show experience providing two categories of resources. We would like to request clarification on the statement provided after bullets e) and f). Are we correct in understanding that for referenced contracts, bidders can have provided one or more programmer/analysts (L2 or L3) for a minimum of 120 billable days, OR one or more testers for a minimum of 120 billable days, as long as both categories are included in the reference contract provided?

e) Have provided one of more Programmer Analyst (Level 2 or 3) in which each resource has a minimum of 120 billable days for a period of one year; and

f) Have provided one or more Tester (Level 3) in which each resource has a minimum of 120 billable days for a period of one year.

It is acceptable if an identified Contract demonstrates either a Programmer Analyst (Level 2 or 3) or a Tester (Level 3) as long as each of these resource categories is demonstrated through a reference Contract that meets all the requirements of MTC1.

**Answer 16:**

The Bidder must demonstrate that it has provided services for **both** resource categories. For example: the Bidder can demonstrate Programmer Analyst through Reference Contract "A", and demonstrate Tester through Reference Contract "B", or demonstrate both categories through the same reference contract.
