AMENDMENT NO. 007

This amendment is raised to answer bidders' questions.

QUESTIONS AND ANSWERS

Question 18:

For MTC1 in all Workstreams, would the Crown allow vendors to use Level 2 or Level 3 resources they've placed as long as the identified resources performed the tasks identified within the RFP SOW and met the minimum number of billable days?

Answer 18:

Your request was considered but the requirement remains unchanged

Question 19:

We reviewed this RFP and we are very interested in the cyber security stream. Generally most cyber security contracts does not exceed couple hundred thousand dollars however MTC1 states the following:

Bidder's Experience Using one or more reference Contract(s), the Bidder must demonstrate that it has provided Cyber Protection Services in the past seven years as of bid closing date as follows:

1. Each Contract identified must:
 - a) Have been with a single client;
 - b) Have an initial minimum value of \$2,000,000.00 (CDN) excluding applicable taxes, not including amendments;
 - c) Have an initial minimum Contract Period of one year, not including amendments;
 - d) Have been completed or ongoing in the last seven years (as of bid closing date);
 - e) Have provided one or more IT Security TRA and C&A Analyst (Level 3) in which each resource has a minimum of 120 billable days for a period of one year; and
 - f) Have provided one or more IT Security Design Specialist (Level 3) in which each resource has a minimum of 120 billable days for a period of one year.

Given the lower contract value of most cyber security engagements and the number of resources Transport Canada is looking for in cyber security work stream, we respectfully ask Canada to lower the contract value to \$500K. This would also help small and medium companies compete for Canada's business,

Answer 19:

For Workstream 3 - Cyber Protection Services, MTC1, 1. b); the \$2,000,000.00 (CDN) has been lowered to \$500,000.00 (excluding applicable taxes, and not including amendments).

For Workstreams 1, 2, 4, 5, 6, and 7, MTC1, 1.b) remains at \$2,000,000.00 (excluding applicable taxes and not including amendments).

Note: The required MTC1, 1.b) revision for Workstream 3 – Cyber Protection Services will be published through a solicitation amendment.

Question 20:

It is clear in the RFP that if we are submitting a bid for all the workstreams we have to have a separate Technical Bid for each workstream.

Do we also have to submit a separate bid for each workstream for the Certifications and the Financial bid?

Answer 20: Each workstream should have its own Technical Bid, Financial Bid, and Certifications.

Question 21:

Workstream 3 – MTC1 states, “It is acceptable if an identified Contract demonstrates either an IT Security TRA and C&A Analyst (Level 3) or an IT Security Design Specialist (Level 3) as long as each of these resource categories is demonstrated through a reference Contract that meets **all the requirements of MTC2**”.

Please confirm that this is a typo, and that the reference Contract needs to meet all the requirements of MTC1 and not MTC2, as seen across Workstreams 1, 4, 5, 6 and 7.

Answer 21: Confirmed. This is a typo.

ALL OTHER TERMS AND CONDITIONS REMAIN THE SAME.
