Q1. Sweeping will not be done through the standing offer this year because it won't not be awarded in time

R1. We are confirming that road sweeping will not be part of the Standing Offer this spring as the Standing Offer will not be awarded in time.

Q2. What are the hours of operation? Can not start until 4pm

R2. We are confirming that in areas where there are client (employee) vehicles, lawn mowing services cannot start in those areas until after 5 pm.

Q3. Property line is not clearly defined on the map that it posted

R3. We currently do not have an updated map available. In 2017 -18 the road into the St. Andrews Biological Station was redesigned. Attached is the Engineering drawing showing Marine Science Drive. The road on the drawing starts at the Brandy Cove Intersection and both sides of this road are included in the Standing Offer.
