AMENDMENT 003

This amendment is raised to answer questions from potential bidders.

Question 2:

Reference:

- 3.2.3 Kneepad. *The removable kneepad must fit securely in the knee pad casing. Airflex Combat Knee Pads style: PAD-KC3 from Crye Precision, NSN: 8465-01-613-2824, colour Khaki with flexible cap, has been known to meet this requirement.*
- 3.2.1.4 *The Contractor must provide one (1) pair of elbow pads, sealed sample PAD-EF3, Elbow Pad, Airflex, Lightweight, NSN: 8315-01-630-5217, for each ASARU Light Weight and Heavy Weight Shirt.*
- 3.2.1.5. *The Contractor must provide one (1) pair of knee pads, sealed sample PAD-KC3-01-00 Kneepad, Airflex, Combat, NSN: 8465-01-613-2824, for each ASARU pant.*

It appears that the technical requirements are written specifically around the Cry Precision garment.

Is it your intent to Purchase the Cry Precision Garment or to allow for garments that are equivalent or better in design and features to compete?

Answer:

The Cry Precision Airflex Combat Kneepads, PAD-KC3, and Elbow Pads, PAD-EF3, will be standard issue for use with the garments. The manufacturer will be responsible for designing a garment that is equivalent or better in design and features, providing that the Airflex Kneepads and Elbow Pads are effectively incorporated into the design.

ADDITIONAL AMENDMENTS TO ANNEX C, ANNEX D AND ANNEX D ARE AS FOLLOWS:

1. **DELETE from Annex C**, Manufacturing Data for Shirt, Heavy-Weight Advanced Search and Rescue Uniform (ASARU) NSN 8415-20-010-0442 A/A, section 3.2.3, Elbow Pad, in its entirety and **REPLACE with the following:**

3.2.3 Elbow Pad. The shirt must be designed with an elbow pad casing which has a secure fit for Airflex Combat Elbow Pads, PAD-EF3, NSN: 8315-01-630-5217, available from Crye Precision.
2. **DELETE from Annex D**, Manufacturing Data for Shirt, Light-Weight Advanced Search and Rescue Uniform (ASARU) NSN 8415-20-010-0451 A/A, section 3.2.3, Elbow Pad, in its entirety and **REPLACE with the following:**

3.2.3 Elbow Pad. The shirt must be designed with an elbow pad casing which has a secure fit for Airflex Combat Elbow Pads, PAD-EF3, NSN: 8315-01-630-5217, available from Crye Precision.
3. **DELETE from Annex E**, Manufacturing Data for Pant Advanced Search and Rescue Uniform (ASARU) NSN 8415-20-010-0479 AA, section 3.2.3, Kneepad, in its entirety and **REPLACE with the following:**

3.2.3 Kneepad. The trousers must be designed with a kneepad casing which has a secure fit for Airflex Combat Kneepads, PAD-KC3, NSN: 8465-01-613-2824, available from Crye Precision.

Question 3:

What is the type of fabric used in the manufacturing of the garment? Who is the supplier of this fabric currently? Who's the current supplier for the uniform and what's the total dollar value? Can you send me a picture?

Answer:

The fabrics are specified in Annexes C, D, E, F and G. This is a new uniform. Sealed samples are available for viewing by contacting PSPC regional offices.

The fabric specifications are performance-based specifications that allow multiple fabric solutions. With performance based specifications, it is the bidder's responsibility to identify compliant products and their sources of supply.

Question 4:

Reference: Colour of the knit material for the torso under DSSPM 2-6-87-0442 (14-02-2019), Para 3.2.1.2, the colour used on the light weight shirt must be khaki in accordance with FED-STD 595#20180.

Is it possible to send to us a swatch of the knit material for the specific requested colour?

Answer:

We do not have a fabric sample since this is a new item, described by performance-based specifications, for which there will be more than one possible compliant product.

The federal standard colour chip FED Std-595C #20180, referenced in the fabric specification DSSPM 2-2-80-249 (Annex G), illustrates the required colour. All bidders are to use this reference colour chip for colour matching.

Question 5:

If a swatch for the knit material colour is not available, can we follow the knit colour of the search and rescue technicians shirt DSSPM 2-6-87-0442 dated 19 June 2017?

Answer:

The federal standard colour chip FED Std-595C #20180, referenced in the fabric specification DSSPM 2-2-80-249 (Annex G), illustrates the required colour. All bidders are to use this reference colour chip for colour matching.

All other terms and conditions remain unchanged.
