AMENDMENT NO. 009

This amendment is raised to answer Bidders' questions.

QUESTIONS AND ANSWERS:

Question 101:

With respect to RTC1 the Crown has confirmed that Bidders can leverage non TBIPS contracts with similar roles to those under each stream in the RFP.

The listing of tasks by resource category is unique to public sector contracts. Crown agencies and private sector employers often request us to provide resources in more general resource categories defined by experience (e.g. Senior Consultant) and request specific deliverables (e.g. disaster recovery plans, release schedules).

In order to demonstrate the placement of similar resources, will the Crown confirm Bidders can demonstrate placement of similar resources for RTC1 by:

- mapping tasks in the SoW to deliverable and/or related requirements in a contract; and
- demonstrating the resource has 10+ years of experience.

Answer 101:

Canada will accept mapping tasks in the SOW to deliverables and/or related requirements in a contract and demonstrating that the resource has 10+ years of experience in the similar resource category.

Question 102:

In Amendment 6 there were numerous questions regarding the resource category level required when responding to RTC1 for both streams. The Amendment 5 with revised evaluation criteria did not exactly clarify this question. Can you please confirm, if demonstrating the same TBIPS resource category (ie. B.14 Technical Writer), is it necessary to provide a resource at the same level (ie. Level 3)? For example if a bidder provided the name of a resource they had placed as a B.14 Technical Writer, Level 1 (same TBIPS category, but different level than required in the RFP), would the bidder be awarded points for this resource as this resource would automatically be considered to be 80% aligned with the SOW tasks of this requirement? Or would this be considered a "similar category" due to the different level and therefore mapping would be necessary?

Answer 102:

For same resource categories, Canada will automatically consider referenced resource categories, procured through the TBIPS contracting vehicle, to be 80% aligned with the SOW tasks of this requirement if they are the same resource category and level. If the resource category is the same as a TBIPS category but a different level than required in the RFP, then it is considered to be a similar resource category. For a similar resource category, mapping and demonstrating 10+ years of experience is required.

Answer 103:

For a similar resource category at the same level (level 3), bidders are required to demonstrate 10+ years of experience.
