3. Section 01 14 00 – Work Restrictions

- 3.1. Subsection 1.5 – Lane Closures and Restrictions – add new article 1.5.7 as follows – “From June 17 to July 5 (or in the event of operational necessity as required to be coordinated in advance), access to Major's Hill Park and Nepean Point (through the entrance to the National Gallery of Canada) must be provided to Canadian Heritage and its suppliers for the Canada Day preparations. During complete road closures or

when there is only southbound traffic, the Principal Contractor must temporarily relocate their traffic control from Sussex Drive and install it north of the entrance to Major's Hill Park. During these road closures, Canadian Heritage will assign a qualified individual to control access to the closed portion of the street so that Canadian Heritage and its suppliers can travel from Sussex Drive to Major's Hill Park and Nepean Point. A coordination meeting will be scheduled in late May or early June with the Departmental Representative, Principal Contractor, Canadian Heritage and its suppliers.”

- 3.2. Subsection 1.6 – Restrictions and Closing of the Pedestrian and Cycling Lane – add new article 1.6.4.1 as follows – “While the Boardwalk steel grating repairs are being completed from Floorbeam 1 to Floorbeam 48, the contractor shall maintain a minimum 1.2 meter horizontal clearance for pedestrians and cyclists at all times. During this clearance reduction, the contractor shall employ flag personnel to safety escort pedestrians and cyclists through the work area.”
- 3.3. Subsection 1.7 - General Construction Restrictions - add new article 1.7.7 as follows – “The Contractor shall ensure local and global stability of the structure due to temporary construction loads imposed on the structure during simultaneous execution of repairs to the boardwalk (Contract Drawings S54 to S56) and to the remaining steel structure (Contract Drawings S08 to S53).”
- 3.4. Subsection 1.7 - General Construction Restrictions - add new article 1.7.8 as follows – “Any stored flammable or combustible materials and products must be removed from the bridge from June 30th at 9pm to July 2nd at 5am. An inspection of the site by the Fire Department of Ottawa and/or Gatineau will be required in preparation of the fireworks. The principal contractor must grant access to the Fire Department to the construction zone for the purpose of completing this inspection.”
- 3.5. Subsection 1.8 – Timing of Work – add new article 1.8.5 as follows – “The Boardwalk steel grating repairs from Floorbeam 30 to Floorbeam 48 shall be completed prior to June 30, 2019. The remaining repairs between Floorbeam 1 to Floorbeam 30 shall be completed prior to the end of the contract.”
4. Section 01 14 25 – Designated Substances
 - 4.1. Subsection 1.3 – Designated Substances - add new article 1.3.12.2 – “The Contractor shall take their own representative number of samples prior to the start of work to confirm lead concentrations in the specified work areas of the project. Testing results will be provided to the Departmental Representative for their records.”
5. Section 06 05 73 – Wood Treatment – entire section has been added to the specifications
6. Section 06 10 53 - Miscellaneous Rough Carpentry – entire section has been added to the specifications
