NOTE TO ALL BIDDERS:

The University of Toronto will be responsible for the bar services. Therefore, it is no longer necessary for the Bidders to have a valid liquor license to serve alcohol in the Toronto Region, nor a valid Special Occasion Permit (SOP). The Contractor must still provide and deliver the reception service, but is not responsible for the cash bar, nor for serving any assorted alcoholic and non-alcoholic beverages (except for water). This is no longer a requirement.

As a result, the Solicitation Amendment 002 serves to:

- 1. Answer questions raised by the Industry (questions 8 to 11);**
- 2. Modify Mandatory Criteria #1 of Table 2 - Mandatory Technical Evaluation Criteria that should be provided at Bid Closing; and**

Question #008:

Can you confirm if attendees will be paying for their drinks at the reception separately?

Answer #008:

The University of Toronto will be responsible for the bar services. This is no longer a requirement.

Question #009:

Please confirm if a storage room can be made available on site?

Answer #009:

Yes, a storage room will be made available on site starting May 8, 2019.

Question #010:

Is an empty bar available on site?

Answer #010:

The University of Toronto will be responsible for the bar services. This is no longer a requirement.

Question #011:

Is price of tables, dishware (plates, cups, etc.), cutlery and skirting to be included in the unit rates for meals?

Answer #011:

Yes, the price of tables (if necessary), dishware (plates, cups, etc.), cutlery and skirting is to be included in the unit rates for meals. Also, as per the note in Annex "B" Basis of Payment, the total bid prices must include all direct and indirect costs to provide the Work outlined in Annex "A" Statement of Work. Rates must also include all food, beverages, tips, gratuities, labour charges, transportation charges, taxes, overhead/administrative charges and profit. This also includes all other equipment necessary to the completion of the work, such as, but not limited to, the cutlery, the table linens and cloths to accommodate approximately 329 attendees, and 50 5-foot long round tables.
