## **PART 1 - GENERAL INFORMATION**

### **1.1 Statement of Requirement**

Defence Research and Development Canada (DRDC) has a requirement for an automated weather station (AWS) that can operate continuously under harsh environments in the Arctic as specified in Annex A.

### **1.2 Debriefings**

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days from receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

### **1.3 Trade Agreements**

The requirement is subject to the provisions of the Canadian Free Trade Agreement (CFTA).

### **1.4 epost Connect service**

This bid solicitation allows bidders to use the epost Connect service provided by Canada Post Corporation to transmit their bid electronically. Bidders must refer to Part 2 entitled Bidder Instructions, and Part 3 entitled Bid Preparation Instructions, of the bid solicitation, for further information.

## **PART 2 - BIDDER INSTRUCTIONS**

### **2.1 Standard Instructions, Clauses and Conditions**

### 2.3 Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than 5 calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

### 2.4 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Nova Scotia.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

## PART 3 - BID PREPARATION INSTRUCTIONS

### 3.1 Bid Preparation Instructions

Bidders must provide their bid in a single transmission. The epost Connect service has the capacity to receive multiple documents, up to 1GB per individual attachment.

If there is a discrepancy between the wording of the soft copy on electronic media and the hard copy, the wording of the hard copy will have priority over the wording of the soft copy.

- If the Bidder is simultaneously providing copies of its bid using multiple acceptable delivery methods, and if there is a discrepancy between the wording of any of these copies and the electronic copy provided through epost Connect service, the wording of the electronic copy provided through epost Connect service will have priority over the wording of the other copies.

### **Section I: Technical Bid**

In their technical bid, Bidders should explain and demonstrate how they propose to meet the requirements and how they will carry out the Work.

### **Section II: Financial Bid**

Bidders must submit their financial bid in accordance with the Basis of Payment.

### **4.2 Basis of Selection**

#### 1. TITLE

Autonomous Weather Station

#### 2. BACKGROUND

Defence Research and Development Canada (DRDC) operates a science station and neighboring aircraft runway at Gascoyne Inlet, Devon Island, Nunavut (NU). Accurate weather reporting is essential for safe air travel to and from the station. Additionally, knowledge of weather conditions during vacant periods is crucial for accurate performance analysis of autonomous equipment and studies. Currently, the closest weather station is in Resolute, NU (108km west). Separated by mountains and open water, Resolute and Gascoyne Inlet have entirely different daily weather conditions. Installation of an Autonomous Weather Station (AWS) for Gascoyne Inlet will result in a safer facility with a more accurate picture of conditions affecting work being done. An AWS with the additional capability of being deployed on ice flows would serve to further enhance our understanding of conditions affecting work in the Arctic.

2	AWS batteries must have the ability to be replaced or recharged by DRDC personnel.
3	AWS must remain operational for the 11 consecutive months the science station is unmanned.
4	AWS must remain operational at -40°Celsius.
