**ADDENDUM NO. 001  
TO THE BID DOCUMENTS FOR**

Public Service and Procurement Canada  
Operations Centre Helipad Improvements

Date: April 26, 2019

1. PRECEDENCE

This Addendum forms and integral part of the Bid Documents and is to be read in conjunction therewith. Where there are direct conflicts between this Addendum and the Bid Documents, this Addendum shall take precedence.

2. RECEIPT OF THIS ADDENDUM

Complete Clause 15, Part II – Bid Form, acknowledging receipt of this Addendum and that the Bidder has considered the contents in the preparation of the Bid.

3. AMENDMENTS

(1) Amended clause 1.7.1 of Section 01 29 00 with:

“The unit price bid for “Topsoil” shall be considered full compensation for installation of 150 mm depth on the pad and 20-40 mm on the side slopes of Stockpiled Site Topsoil or any required Imported Topsoil, and fine grading, and includes all labour, materials and equipment, tools and incidentals necessary to complete the Work to the satisfaction of the Departmental Representative.

(2) Delete the following clause in article 1.5 of Section 01 51 00:

“Arrange for tie-in with appropriate utility owner and pay costs for connection.”

(3) New Addition clause 1.11.1 of Section 01 61 00 with:

.1 “When breaking into or connecting to existing services or utilities, execute Work at times directed by Parks Canada Project Representative, with minimum of disturbance to Work, building occupants and pedestrian and vehicular traffic.

.1 Services include irrigation water supply and power supply. Both services will be sourced from the Water Chlorination Building adjacent to the Helipad.”

(4) Delete article 1.1 in Section 03 20 10:

.1 “1.1 REFERENCE STANDARDS

.1 Complete reinforcing work in accordance with CAN3-A23.1.”

(5) Delete clause .2 in 1.4 in Section 03 20 10:

.1 “Upon request submit in writing to Departmental Representative proposed source of reinforcement material to be supplied.”

(6) Replace clause 3.3 of Section 05 50 00 with:

.1 “The following listing of metal fabrications is provided by the Engineer for the convenience of the Contractor. Every attempt has been made to provide a complete list metal fabrications; however, it and is not intended to be comprehensive listing, which is

the Contractor's responsibility; list of metal fabrications includes; but is not limited to, the following:

- .1 Loose Bearing and Levelling Plates: Provide plates for steel items bearing on masonry or concrete construction; drill plates to receive anchor bolts and for grouting.
- .2 Miscellaneous Framing and Supports: Structural steel shapes, plates, and bars of welded construction; galvanize where located in exterior construction; fabricated to sizes, shapes, and profiles necessary to receive adjacent construction retained by framing and supports; cut, drill, and tap units to receive hardware, hangers, and similar items including but not limited to the following:
  - .1 Steel framing and supports for applications where framing and supports are not specified in other Sections
  - .2 Steel angle corner guards (non-decorative)
  - .3 Miscellaneous steel trim
  - .4 Steel floor plate and supports

(7) Delete clause.2 of 3.1.1.4 in Section 31 05 16:

"Parks Canada Agency will make additional space available for aggregate stockpiles at the Upper Compound, which is approximately 3.5 km from Waterton Townsite Campground."

(8) Delete clause .18 of Part 3 in Section 31 14 13:

"Topsoil stored for longer than two (2) years shall be cleaned of all surface vegetation, shredded, spread, rototilled to a friable consistency before placement on site."

(9) Replace Article 2.5 description with:

"NON-SHRINK/UNSHRINKABLE FILL"

(10) Amended clause 3.4.2:

"Embankment material shall be Class 1 Backfill."

(11) New Addition clause 3.9.6 of Section 32 23 13:

"Each lift (150 mm or 300 mm) of fill, subgrade or crushed gravel must have a compaction test successfully completed."

(12) Delete the following articles from Section 31 23 33:

- 1.3 Definitions
- 1.5 Soils Information
- 1.6 Samples
- 3.7 Compaction
- 3.8 Backfill Compaction Testing

(13) Amended clause 3.6.2:

"The tolerance for ditches, etc., shall be  $\pm 50$  mm.
