Question 1.

Supplier would like request an extension of the closing date by 15 days to 15th May 2019.

Answer 1.

As indicated in the tender Notice for Rigid Hull Inflatable Boats (RHIB) and Inflatable Boats (IB) (E60MC-190001/A); The Request for Supply Arrangements (RFSA) is to establish Supply Arrangements for the delivery of the requirement detailed in the RFSA to the Identified Users across Canada, excluding locations within Yukon, Northwest Territories, Nunavut, Quebec, and Labrador that are subject to Comprehensive Land Claims Agreements (CLCAs). Any requirement for deliveries to locations within CLCAs areas within Yukon, Northwest Territories, Nunavut, Quebec, or Labrador will have to be treated as a separate procurement, outside of the resulting Supply Arrangements.

All arrangements submitted under this Request for Supply Arrangements (RFSA) will be evaluated by Canada. Suppliers meeting the mandatory requirements will be placed on the Supply Arrangement (SA). Only suppliers who have been **pre-qualified** and have been awarded an SA will be allowed to submit bids for individual Requests for Proposals (RFPs).

Considering this procurement process is to establish a list of qualifies suppliers with an **on-going opportunity for qualification on a quarterly basis**, as per the solicitation article 6A.7, the bidder's request is declined. Solicitation closing date will remain the same.
