This amendment is issued to answer bidders' questions.

Q1: We would like to ask if the Crown has, or will, issue a NON-SET ASIDE for this solicitation.

A1: The crown has not and has no intention to issue a NON-SET ASIDE for this solicitation.

Q2: If we are only able to provide candidates for the positions in the RFP that require a resume (9 positions) are we still permitted to bid? What happens if we are not able to provide a suitable candidate after award for positions we did not submit a resume's for?

A2: Upon request, the contractor must be able to provide individuals to perform the work of any required and optional resource categories in order to comply with the terms of the contract. The individuals must meet the qualifications and experience identified in the flexible grid.

Q3: Do we need to provide consent forms for the resources included in our bid, or can we request consent following award?

A3: Please refer to the second paragraph of section 5.2.3.1 for this information. The Contracting Authority can request the consent forms at any time during the entire process.
