QUESTION 4

CALL FOR TENDERS – CONSTRUCTION – ADDENDUM 2

1. General

- 1.1. This addendum includes modifications made to drawings and specifications. These modifications must be implemented in accordance with contract documents.
- 1.2. Contractor to include all modifications described below in his tender and adjust its price and schedule, if required.
- 1.3. This addendum follows documents issued on March 14 and 18, 2019.

2. Revisions

2.1. Technical specifications:

2.2.1 Section 01 35 29.06 - Health and Safety Requirements (art. 1.13.3), Section 01 35 43 – Environmental procedures (art. 1.20.4), Section 01 52 00 – Construction facilities (art. 1.13.5)

The required signaling and marking buoys must include bright yellow warning buoys installed on each side (upstream / downstream) of the end of each jetty that will be kept functional for the duration of the work.

2.2.2 Section 01 11 01 – Summary of Work

Article 1.12.1.12: " Contractor to provide Departmental Representative with motorboat (rigid hull inflatable-type [RIB]) of 5.5 m or greater, including consumables and maintenance, for the entire duration of Work."

is replaced by:

"The Contractor shall provide the Departmental Representative with a Rigid Hull (RIB) motorized watercraft of 5.5 m or greater, including consumables and maintenance, for the entire duration of the work. The contractor is responsible for the operation of the boat and will have to transport the Departmental Representative, according to his needs during the work. It will have to ensure its transport between the transshipment site and the work zone, as well as to circulate on the body of water according to the needs of the supervisor."

2.2.3 Section 01 29 00 – Payment Procedures

Article 1.5.2.4.4.1: ~~25%~~ of the lump sum for the development of each jetty (~~50%~~ in total)

is replaced by:

37.5 % of the lump sum for the development of each jetty (75 % in total)

Article 1.5.2.4.4.2: ~~25%~~ of the lump sum for the maintenance, removal and disposal of all backfilled material at each of the jetties (~~50%~~ in total).

is replaced by:

12.5% of the lump sum for the maintenance, removal and disposal of all backfilled material at each of the jetties (25% in total).
