This amendment is issued to publish questions and answers.

Questions and Answers:

QUESTION 1: "Request for Substitution to use Dörken Systems Inc DELTA®-VENT SA self-adhering vapour permeable air barrier"

RESPONSE 1: Dorken product is an acceptable alternate provided the contractor considers all the interfaces and other adjoining materials. Contractor must provide written confirmation that the product is compatible with ICF. Use of proposed product requires that manufacturer's compatible tapes, sealants and other Self-adhered membrane products also used.

QUESTION 2: IKO Industries Ltd. request for alternate products, specifically sections in division 7 of the specifications, to be considered an acceptable manufacturer offering equivalent products to the specified manufacturers- Soprema and 3M.

RESPONSE 2: Prior to acceptance of the IKO industries Ltd. products as listed in IKO request for alternate products submittal package, IKO Industries is required to provide revised details of assemblies and details shown on drawings BE 000, BE 001, BE 002, BE003 and BE004 with the appropriate IKO products. Additionally, submission of written demonstration that the proposed products are suitable with each application is required. We have concerns with the application of the proposed products with the ICF system with respect to the longevity of the new VP SA membrane. The supplier has not provided information related to compatible sealants at this time. Substitution of products from those listed in the specifications will not be considered when the supplier does not demonstrate consideration for the adjoining products nor the assembly which they tend to do. Providing a list of materials and spec sheets is insufficient evidence that the supplier has reviewed the specific application for each material.

QUESTION 3: Request for alternate specification for overhead doors to use Amarr® KnockOut Doors.

RESPONSE 3: Submission does not demonstrate compliance with performance requirements listed in Section 08 36 16. Request for alternate product is not accepted.

QUESTION 4: Engineer's spec (Section 26 31 00. Item 1.3) for fire alarm makes reference to both 2-stage and single stage. What is the correct requirement?

RESPONSE 4: System is to be single stage.

All other terms and conditions remain unchanged.
