**Question:**

Could the Bid Closing date be extended to May 15th?

**Response:**

Please refer to Solicitation Amendment 001. Closing date is May 17, 2019.

**Question:**

- a) Do we have approval from First Nation communities to execute the work and can we have contact information for First Nations whose traditional territories fall with the site?
- b) Are there First Nation communities that this work falls on their Territories that would be interested in looking at being involved in the bid?

**Response:**

a) and b): Yes. CCG has engaged first nation communities who have traditional territories on the CCG site and has obtained necessary approvals from the Province via a section 16 of the Land Act. Due to the remoteness of the location of the CCG site, it passes through the traditional territories of the First Nations belonging to the Namgis, Da'naxda'xw Awaetlatla, and Tlowitsis. Bidders are encouraged to employ the available local workforce and utilize other locally available resources and equipment. For information, please contact Rachael Dalton who represents the Namgis at [RachelD@namgis.bc.ca](mailto:RachelD@namgis.bc.ca) and Art Wilson, Nanwakolas Council at [artwilson@nanwakolas.com](mailto:artwilson@nanwakolas.com) who represents the Da'naxda'xw Awaetlatla, and Tlowitsis first nation communities.

**Question:**

Can we access the site during the solicitation period?

**Response:**

Yes; however this must be approved and coordinated with the CCG Representative.

**Question:**

How large is the land tenure size i.e. the approved section 16 of the Land Act?

**Response:**

See attached drawing for information.

**Question:**

Are we allowed to clear trees within the land tenure area i.e. the approved section 16 of the Land Act?

**Response:**

Yes. CCG has obtained cutting permits from the Province; however the Contractor must follow application regulations such as, but not limited, to SARA and BC Wildlife Act where birds and bird nests could be impacted.

**Question:**

For the Heli muster landing area, are we allowed to extend the existing area larger to allow for more storage away from the work area?

**Response:**

Yes. The extended area *must* be coordinated and confirmed with CCG.
