Request for Proposal Amendment no. 002 is raised for the following reasons: Questions and answers.

Question 9:

1 hour to respond to a service call, 4 hours from time of service call to have a technician at the print site if required and 8 hours to resolve problem allowing IRB to continue operations at minimum 80% capacity except on written agreement by the identified user.

Would the end user accept a hot spare as a solution to this requirement?

Answer 9:

In review, those would not apply, since all province have spares and would replace a defective model in a police car themselves and would not get any on-site service. We would return the unit to the vendor for them to repair.

So a hot spare could be an option.
