- f) *The start and end dates for the Initial Contract Period, not including amendments;*
- g) *The total initial minimum value (excluding applicable taxes) of the Initial Contract Period, not including amendments;*
- h) *The resource categories provided under the Contract and a brief description of their tasks;*
- i) *The first and last name of the resource cross referenced against the resource category in Annex A of this Bid Solicitation (for categories outside of the Workstream, provide the first and last name of each resource);*
- j) *The total number of days billed per resource under the Contract; and*
- k) *For similar categories, the mapping of the SOW tasks of this requirement to the tasks of the resource category identified in the reference contract.'*

Several of the contracts that we wish to reference account for several resource categories (including the categories per respective workstream) and billable days far exceeding the minimum 2,000 billable days required in a given three-year period. Please confirm that, specifically, for:

f) and j) above - Refers only to the three-year billing period that supports a total of at least 2,000 billable days?

h) and i) above - If the Bidder can meet and/or exceed the 2,000 billable days in the workstream specific, categories (i.e., WS2 - Project Managers), they do not have to provide the names or brief description of tasks for other resource categories that are outside the workstream specific categories?

Answer 102:

In terms of f) and j) Canada will require that the billing period be limited to up to three years for demonstrating the required billable days and will only require 2000 billable days. Should the Bidder provide a reference contract that is for more than 2000 billable days they will have met the requirement for f) and j) but the additional billable days will not be reviewed.

In terms of h) and i), the Bidder must identify the first and last name of the resource cross referenced against the resource category in Annex A of this Bid Solicitation (for categories outside of the Workstream, provide the first and last name of each resource).

Question 103:

For RTC2, RTC3 & RTC4 please confirm a contract that was awarded in 2010 but ongoing within the last 7 years would be an accepted reference given the risk strategy, contract management plan and talent management plan were implemented and the practices on-going through the duration of the contract. Alternately would you amend RTC2, RTC3 & RTC4 tohas been implemented in IT Professional Services Contracts within the past ten years as of bid closing.

Answer 103: Your request has been considered but the requirement remains unchanged.
