Solicitation Amendment No. 02

This solicitation is also hereby amended to provide the following questions and answers:

Q1. Please define what is meant by "Between Meal Allowance" requested in Annex 1 Requirements.

A1. Between Meal Allowance is referring to snack that is provided to the cadets between meals. This usually constitutes a juice and fruit with the occasional cookie.

Q2 Annex "A"- Minimum Staffing Standard provides a Minimum Staffing Chart on page 2. May we provide a more efficient staffing chart? For instance, the period August 22 – August 28, the minimum staffing chart shows a total staff number of 12 personnel to feed an anticipated 25 guests.

A2. As stated in Paragraph 1 C. "The following is a guide, supplied from A-85-269-001FP-006 is used as a suggested staffing guide. You are not required to provide a more efficient staffing chart but MUST fulfill the requirements as specified in the contract.

Q3 Annex 3 – Mandatory Requirements – Item 1 f) states: "Provide a Standardized recipe file for quantity food preparation for all items included in the "three week cycle menu". We use the DND National Standardized Cycle Menu Recipe Book at all of the cadet camps we serve. Is it sufficient to reference this recipe book in our response to this requirement?

A3. Yes. It is acceptable to use the DND National Standardized Cycle Menu Recipe Book.
