Q: Can you please clarify the following statement under RT1 Management of Services – The Bidder should substantiate: c) “Its proposed methods for preventing financial disputes/claims against PWGSC by A&E consultant firms and construction firms.” Why would a company being contracted by PWGSC under a Project Management Support Services contract be obligated to resolve disputes between PWGSC and A&E and construction firms?

A: The winning bidder is not and will not be asked to resolve disputes between PWGSC and other entities. However, we ask bidders to propose methods that will prevent financial disputes/claims against PWGSC by other entities such as A&E consultant firms and construction firms.
