2nd draft RFP – Questions and Answers
In-Service Support of the *Halifax*-class Combat Systems
Amendment no. 31

This amendment is raised to obtain additional feedback from Industry pertaining to the second draft Request for Proposal.

Question from Canada to Industry

In order to achieve best value to Canada, the following changes have been made to the Financial Evaluation section of the Request for Proposal:

- a) In section 4.3.3.1.1, the threshold used to determine the exclusion of hourly labour rates from the calculation of a bidder's Adjusted Average All-Inclusive Hourly Labour Rate, has been **increased from 35%** below the median of all submitted hourly labour rates **to 40%** below the median of all submitted hourly labour rates.
- b) In section 4.3.3.1.2, the threshold used to determine the allocation of points for the Management fee score, has been **increased from 35%** below the median 12 year Total Management Fee **to 40%** below the median 12 year Total Management Fee.
- c) In sections 4.3.3.1.3 and 4.3.3.1.4, bidders will no longer need to submit their mark-ups for both subcontractor and material costs. Instead, a fixed 5% mark-up rate will be applied to both subcontractor and material costs for the entire contract period.

Q1 – Could CANADA provide an updated schedule?

A1 – CANADA has received approval to release the final RFP from the Defence Procurement Strategy (DPS) Director General Governance Committee (DGGC) meeting that was held on May 14th, 2019. CANADA plans to release the final RFP at the end of May/early June. Answers to the remaining Q&A will be released sometime in June 2019 after the release of the final RFP.
