## **Solicitation Amendment 001**

This amendment is being raised to 1) incorporate an Extension of Time for the receipt of proposals, 2) incorporate changes to section SRE 2.2 of the Request for Proposal, and 3) provide responses to Requests for Clarification.

### **1. Extension of Time**

Notice is hereby given that the closing date for the reception of proposals previously due Wednesday, June 19, 2019 is extended to **14:00 hours, Thursday June 20, 2019.**

### **2. SRE 2 Proposal Requirements; 2.2 Phase One Specific Requirements for Proposal Format**

#### **2.2 Phase One Specific Requirements for Proposal Format**

The maximum number of pages (including text and graphics) to be submitted for the Rated Requirements under SRE 3.2 is thirty (30) pages.

### **3. Requests for Clarification**

**Q1.** How much of the Budget of 10M will be for site work and landscaping?

**A1.** The budget for landscaping is estimated to be \$600,000 of the \$10M budget.

**Q2.** Does the budget include for any work on exhibits?

**A2.** Yes, approximately \$2,000,000 of the \$10M budget is estimated for exhibits.

**Q3.** Has the Exhibit Designer been selected already?

**A3.** No, the process of selecting an Exhibit Designer is ongoing.

**Q4.** The security requirements are only required if successful correct? We've had them before on other projects, but would need it again. It says on S16 that it is required at date of bid closing, is that for phase 2 RFP closing?

**A4.** Security Requirements must be met at the date of bid closing for Phase 1 of the RFP.

**Q5.** From our understanding, we must format the Team Identification as Appendix A, but we do not need to use this specific form. Is this assumption correct?

**A5.** Yes, response for SRE 3.2.1 Consultant Team Identification should be submitted in the format of Appendix A – Team Identification.

**Q6.** Will Phase Two responses be required at the same time and date as Phase One? If not, when is its deadline?

**A6.** Proponents should initially submit responses to Phase One only. Following evaluation and rating of these proposals, proponents are advised of their competitive standing and have the opportunity to decide whether or not to continue their participation by submitting a Phase Two proposal. The deadline for submitting Proposals for Phase Two will be provided when Proponents are advised of their competitive standing after the Phase One evaluation.

**Q7.** Are electronic signatures acceptable?

**A7.** Yes.

**Q8.** As per the requirements, we must supply information about 2 relevant projects per 11 sub-consultants and specialists, as well as our own 2, for a total of 24 projects, along with describing our achievements and experience of our key personnel, all using a specific font size. The 20-page restriction could be limiting in order to properly reply to these requirements so would it be possible to extend the limit to 30 pages?

**A8.** Yes, the page limit for Phase One submissions will be increased to 30 pages.

**Q9.** May we supply CVs of our team within an appendix which would not count towards the final page count?

- Q11.** For the required security clearance, we have an existing DOS clearance completed in 2016, will this require updating now being 2019?
- A11.** It is the Proponents responsibility to ensure they meet all security requirements. CISC (Canadian Industrial Security Directorate) can be contacted to determine a Proponent's status.
