Requests for Clarification

- Q8. Are cost estimators considered as sub-consultants? In providing their services, are we expected to solicit at least two proposals, and then add the lowest to our fee proposal, or their fees will be considered as disbursement?
- A6. If Cost Estimator services are to be provided by a sub-consultant then their fees will be considered a Disbursement and will be subject to TP 10 Disbursements.
- Q9. Would you consider somehow reorganizing the RFP so that companies who can successfully cover 95% of the structures are not disqualified because they cannot cover bridges?
- A7. We will not remove bridges from the evaluation criteria at this time.
