





- 2. To ensure consistency and quality of the information provided to Bidders, the Contracting Officer will examine the content of the enquiry and will decide whether or not to issue an amendment.
- 3. All enquiries and other communications related to this bid sent throughout the solicitation period are to be directed ONLY to the Contracting Officer named on the Invitation to Tender Page 1. Failure to comply with this requirement may result in the bid being declared non-responsive.

SI03 REVISION OF BID

SI04 BID RESULTS

- 1. The responsive bid carrying the lowest price will be recommended for contract award.
- 2. CSC will send an official letter by email to unsuccessful bidders to inform them of the name of the winning bidder as well as the total contract value.

SI05 INSUFFICIENT FUNDING

- 1. In the event that the lowest compliant bid exceeds the amount of funding allocated by Canada for the Work:
 - a) by 15% or less, Canada in its sole discretion may:
 - i. cancel the solicitation; or
 - ii. obtain additional funding and, subject to the provisions of GI10 of R2710T, award the Contract to the Bidder submitting the lowest compliant bid; and/or


SI06 BID VALIDITY PERIOD

- Canada reserves the right to seek an extension to the bid validity period prescribed in BA04 of the Bid and Acceptance Form. Upon notification in writing from Canada, Bidders must have the option to either accept or reject the proposed extension.
- 2. If the extension referred to in paragraph 1. of SI07 is accepted, in writing, by all those who submitted bids, then Canada will continue immediately with the evaluation of the bids and its approvals processes.
- 3. If the extension referred to in paragraph 1. of SI07 is not accepted in writing by all those who submitted bids then Canada will, at its sole discretion, either

Correctional Service Canada reserves the right to deny access to any institution/site or part thereof of any Contractor personnel, at any time.

SC02 INSURANCE TERMS

Insurance Contracts

- (a) The Contractor must, at the Contractor's expense, obtain and maintain insurance contracts in accordance with the requirements of the Certificate of Insurance. Coverage must be placed with an Insurer licensed to carry out business in Canada.
- (b) Compliance with the insurance requirements does not release the Contractor from or reduce its liability under the Contract. - (b) The Contractor must be responsible to provide and maintain coverage for Products/Completed Operations hazards on its Commercial General Liability insurance policy, for a period of six (6) years beyond the date of the Certificate of Substantial Performance.

Proof of Insurance

- (a) Before commencement of the Work, and no later than thirty (30) days after acceptance of its bid, the Contractor must deposit with Canada a Certificate of Insurance on the form attached herein.
- (b) Upon request by Canada, the Contractor must provide originals or certified true copies of all contracts of insurance maintained by the Contractor pursuant to the Certificate of Insurance.



5. Deductible

SC03 COMPLIANCE WITH APPLICABLE LAWS:

The Contractor must comply with all laws, regulations rules instructions and directives applicable to the performance of the Work or any part thereof in force on the site where the Work is to be performed. The Contractor must also comply with all laws, regulations, rules, instructions and directives applicable to the agents and servants of the Crown. The Contractor must also require compliance therewith by all of its subcontractors. Evidence of compliance with such laws,

SC07 CLOSURE OF GOVERNMENT OFFICES

Contractor personnel are employees of the Contractor and are paid by the Contractor on the basis of services rendered. Where the Contractor or the Contractor's employees are providing services on government premises pursuant to this Contract and the said premises become non accessible due to evacuation or closure of government offices, and consequently no Work is being performed as a result of the closure, Canada will not be liable for payment to the Contractor for the period of closure.

Contractors working at CSC sites should be aware that they may be faced with delay or refusal of entry to certain areas at certain times even if prior arrangements for access may have been made. Contractors are advised to call in advance of travel to ensure that planned access is still available.

SC08 CONTRACTOR'S PERFORMANCE EVALUATION REPORT





General

The insurance policies required on page 1 of the Certificate of Insurance must be in force and must include the insurance coverage listed under the corresponding type of insurance on this page.

The policies must insure the Contractor and must include Her Majesty the Queen in Right of Canada as represented by the Minister of Public Safety Canada as an additional Insured.

The insurance policies must be endorsed to provide Canada with not less than thirty (30) days notice in writing in advance of a cancellation of insurance or any reduction in coverage.

Without increasing the limit of liability, the policies must protect all insured parties to the full extent of coverage provided. Further, the policies must apply to each Insured in the same manner and to the same extent as if a separate policy had been issued to each.

Commercial General Liability.

The insurance coverage provided must not be substantially less than that provided by the latest edition of IBC form 2100.

The policy must either include or be endorsed to include coverage for the following exposures or hazards if the Work is subject thereto:

- a) blasting;
- b) pile driving and caisson work;
- c) underpinning;
- d) removal or weakening of support of any structure or land whether such support be natural or otherwise if the work is performed by the insured contractor.

The policy must have the following minimum limits:

- a) \$5,000,000 Each Occurrence Limit;
- b) \$10,000,000 General Aggregate Limit per policy year if the policy contains a General Aggregate; and
- c) \$5,000,000 Products/Completed Operations Aggregate Limit.

Umbrella or excess liability insurance may be used to achieve the required limits.

Builder's Risk / Installation Floater.

The insurance coverage provided must not be less than that provided by the latest edition of IBC forms 4042 and 4047.

The policy must permit use and occupancy of any of the projects, or any part thereof, where such use and occupancy is for the purposes for which a project is intended upon completion.

The policy may exclude or be endorsed to exclude coverage for loss or damage caused by asbestos, fungi or spores, cyber and terrorism.

The policy must have a limit that is **not less than the sum of the contract value** plus the declared value (if any) set forth in the contract documents of all material and equipment supplied by Canada at the site of the project to be incorporated into and form part of the finished work. If the value of the work is changed, the policy must be changed to reflect the revised contract value.

The policy must provide that the proceeds thereof are payable to Canada or as Canada may direct in accordance with GC10.2, "Insurance Proceeds" (https://buyandsell.gc.ca/policy-and-guidelines/standards-acquisition-clauses-and-conditions-manual/5/R/R2900D/2).



ANNEX C - Scope of Work

General Information

CORCAN Construction Ontario Region has a requirement to Supply, Place, and Finish miscellaneous concrete components for the construction of a new Multipurpose Building. The jobsite is at Collins Bay Institution, located in Kingston ON.

Background

The Mandate of CORCAN Construction is to provide employment and employability skills training to offenders incarcerated in federal penitentiaries. When deemed appropriate by CORCAN Construction, the Contractor may be required to assist in the Mandate by working with 2-4 Offenders. The Offenders will be supervised by CORCAN. The Offenders will be considered unskilled labour and the Contractor will help them gain knowledge and skills in the trade(s) being carried out. The Offenders are employed by CORCAN Construction and no financial obligations are required of the Contractor as a result of having them as part of the workforce. The Offenders are considered to have the potential to be productive upon receiving training necessary to their work and will be removed or replaced upon request from the Contractor should they not show improvement or interest in the work they are tasked with.

Scope of Work

The Contractor must Supply all labour, material, tools, equipment, transportation, and supervision necessary to complete the Statement of Work as detailed:

Interior

- 1. To supply & install fiber impregnated expansion joint to the perimeter of the building.
- 2. Place and tie all slab on grade steel reinforcement as per drawings and specifications provided. (Steel reinforcement supplied by CORCAN Construction.)
- 3. To place & finish concrete to the 125mm slab on grade.
- 4. To place & finish concrete to the 200mm slab on grade.
- 5. To place & finish concrete to the 150mm slab on metal deck.
- 6. To supply & install hardener to the slabs on grade & slab on metal deck, excluding staff washrooms at rates identified in the specifications document.
- 7. To saw-cut slab on grade.
- 8. To supply a concrete pump as required.
- 9. To supply concrete (25MPa, no air, pump mix, mid-range plasticizer),for 125mm slab on grade & slab on metal deck
- 10. To supply concrete (32MPa, C-2, pump mix, mid-range plasticizer), for 200mm slab on grade.
- 11. Supply and Install cure and sealers as identified in the concrete specifications document.
- 12. Supply and Install joint filler in control joints as identified in the concrete specifications document.

Exterior

Apron Slabs

- 13. To install welded wire mesh, supplied by CORCAN Construction.
- 14. To form, place & finish concrete to the one (1) concrete apron Sloped in one (1) direction, away from the building.
- 15. To supply concrete (32MPa, C-2, pump mix, mid-range plasticizer), for the above mentioned apron slab.

Sidewalks

- 16. To form the exterior sidewalks.
- 17. To place & finish concrete to the one (1) concrete sidewalk with the apron slab.
- 18. To supply concrete (32MPa, C-2, pump mix, mid-range plasticizer), for the above mentioned sidewalk.
- 19. All work must be performed during regular business hours: Monday to Friday 0800 1600 hrs.
- 20. The Contractor must identify a Project Manager who will be responsible for the overall management of the project and must represent the Contractor if required.



- 21. The Contractor must dispose of all waste materials in an environmentally friendly manner. This includes recycling where possible.
- 22. The Contractor must be responsible for the professional quality, technical accuracy, and the coordination of all construction and other services furnished under this contract. The Contractor must, without additional compensation, correct or revise any errors or deficiencies in its construction and other services.
- 23. All materials and equipment incorporated into the project must be new unless noted otherwise. The Contractor must transport and safeguard all materials and equipment required for construction.
- 24. The Contractor is responsible for the professional quality, technical accuracy, and the coordination of all construction and other services furnished under this contract. The Contractor must, without additional compensation, correct or revise any errors or deficiencies in its construction and other services.
- 25. The Contractor must prepare and submit reports, bill of materials, product literature, drawings, specifications, quality control schedules, safety plan and construction costs. These documents must provide the necessary interfaces, coordination, and communication between CORCAN and Contractor for the delivery of a completed project
- 26. All documentation produced for this project will become the ownership of the Crown at the completion of this project.
- 27. The Contractor is responsible for safety and must comply with all local labor laws, regulations, customs and practices pertaining to labor, safety and similar matters. The Contractor must promptly report all accidents resulting in lost time, disabling, or fatal injuries to the CORCAN Project Authority.
- 28. The Contractor must visit the site prior to work commencement for verification of all measurements and materials required to complete the work and to familiarize themselves with the facility.
- 29. The Contractor, if requested by the Technical Authority, must supply samples and certification that all materials furnished fully comply with the specifications identified in the Scope of Work.




