Amendment 004 is raised to revise the technical evaluation criteria as well as provide answers to the following questions:

Question 1:

Section 3.0 B) says that all lights have to meet CISPR25 class 3 or better for Radio Frequency Interference suppression from an accredited radio frequency testing facility.

- Do we have to provide testing results with the bid from an accredited testing facility (i.e. – full test results and/or a certification of compliance), or can we just attest in the bid that the lights meet the specification, with the understanding that full testing documentation may be requested at a later date?
- If we *do* indeed need to provide certification documents for each light type bid, is that for ALL lights or only if we are proposing alternatives to the part numbers that are specified in the bid?

Answer 1:

Documentation of test results must be provided at time of bid. This includes all lights specified in the bid as well as proposed alternatives and part numbers.

Question 2:

ANNEX B - M6: it states must submit a copy of each offered lighthouse manual in English: operating and programming instructions, system wiring diagrams and interconnect diagrams and schematic diagrams complete with component identification for all lights with this bid. Can you please let me know if this is for substitutions only or can this be submitted at time of award?

Answer 2:

Manuals for any substitutions must be included with the bid. Manuals for part numbers specified in the RFP can be submitted at the time of award.

Question 3:

Regarding Annex “B” – Mandatory Technical Evaluation Criteria.

Section M7 states: *The Offeror offers to provide additional manufacturer warranty which exceeds the minimum requirement specified at M3 at no additional cost.*

If you could provide some clarification this it would be helpful. As we understand it from reading this section, we are required to offer a warranty that exceed the minimum 3-year warranty. If one of the products we are proposing has a 3-year manufacturer warranty, which is the requirement under section M3, is that not sufficient? M7 seems to contradict M3 in that M3 says must have 3 year minimum warranty but M7 says we must have in excess of 3 years.

Would it be acceptable to indicate the warranty duration for each of the products that we are proposing (by product group or otherwise), rather than making warranty over the 3-year minimum mandatory?

Answer 3: M7 to be deleted

Question 4:

Section M8 states; The Offeror has an additional repair facility(ies) and support center(s) in Canada for the lightheads over the minimum requirement specified at M5....

Similar to the above question, M8 seems to conflict with M5. M5 states we must have a Canadian location for repair and support of the items being proposed, then M8 states that we must have an additional location within Canada.

Would it be acceptable to indicate additional locations (over and above the one location required in M5) if applicable, rather than making a second location mandatory?

Answer 4: M8 delete in its entirety

Question 5:

I noticed an error in the document <page 47, line 19.5

19.5 Feniex Cannon Feniex Cannon Lens - 180 Degree Lens

Feniex Cannon lenses offer 120 or 360 degrees, not 180. Can you please specify?
