SOLICITATION AMENDMENT NO. 003

This amendment is raised to:

1. Provide answers to Bidders questions in relation to the above mentioned solicitation; and
2. Amend the RFP as detailed in Appendix A-3 below.

Question 2:

With regards to Workstream A and B, page 144-149: A-M2/B-M2/A-R3/B-R3, 2. "The duration must be at least two (2) years within the last eight (8) years from the closing date of this solicitation...", would the Crown please consider revising A-M2, B-M2, A-R3 and B-R3 from "the closing date of this solicitation" to be the same as A-M1/B-M1, "RFP publication date"? This would allow Bidders to keep a firm fixed date range when responding to criteria in the event of any extensions throughout the procurement process.

Response 2:

Canada will amend A-M2, B-M2, and A-R3 to remove "the closing date of this solicitation" to "RFP publication date". See Appendix A-3.

Note that B-R3 had been previously amended. Please refer to Response 1 of Solicitation Amendment 001.

Question 3:

With regards to Form 4 – Customer Reference Contract Information Form, would the Crown please confirm that Bidders are only required to use Form 4 for responses to A-M2/B-M2 and A-R3/B-R3?

Form 4 will be removed. See Appendix A- 3.

Question 4:

With regards, to Form 4 – Customer Reference Contract Information Form: "Contract Information: The Bidder must provide with this form a copy of the reference contract.", in the interests of reducing the size of Bidders' responses, would the Crown please confirm that a copy of the Signed First Page of the Original Contract and a copy of the latest Amendment would be sufficient to meet this requirement?

If “**Form 3** – Electronic Payment Instruments” is not completed, it will be considered as if Electronic Payment Instruments are not being accepted for payment of invoices. Acceptance of Electronic Payment Instruments will not be considered as an evaluation criterion.”*
