This Solicitation Amendment 004 is raised to answer a bidder's question as follows:

- Q1. Respecting the above mentioned tender, in annex B, Deliverables: All contractors must submit a minimum of 5 references on similar emergency vehicle builds which they have completed within the last 5 years with their bid package.
Is it possible that instead of the contractor, the manufacturer provides a minimum of 5 references?
- A1. This amendment changes the wording to allow for different scenarios.

Para 4.1.1 Technical Evaluation, Sub-Para 4.1.1.1 of the RFP is amended as follows:

DELETE: 4) Minimum of 5 references on similar emergency vehicle builds which the bidder has completed in the last 5 years;

INSERT: 4) Minimum of 5 references on similar emergency vehicle builds that have been completed within the last 5 years by the vehicle upfitter.

Annex B - Tactical Troop, Front Line Logistics Support Vehicle dated 11 April 2019, under the heading "deliverables" is amended as follows:

DELETE: All contractors must submit a minimum of 5 references on similar emergency vehicle builds which they have completed within the last 5 years with their bid package.

INSERT: The bidder must submit, with the bid package, a minimum of 5 references on similar emergency vehicle builds that have been completed within the last 5 years by the vehicle upfitter.

ALL OTHER TERMS AND CONDITIONS OF THIS SOLICITATION REMAIN UNCHANGED.
