Question 1:

Section PD 2.11 states that stakeholder consultation processes are not included in the consultant's scope of work. Can you tell us if Parks Canada will be undertaking the stakeholder consultation process during the same time period that the consultant is doing their scope of work, or has this work been done already and you would simply be turning over the findings to the consultant? If it is happening during the same time period, would the consultant be expected to attend any stakeholder consultations facilitated by Parks Canada, and/or provide any materials to be used in those consultations? Or, is there no consultant involvement expected at all other than analyzing the information collected?

Answer 1:

Parks Canada completed its public consultation process as part of its Management Plan 10 year cycle renewal. The relevant outcomes of the process will be provided to the consultant. If Parks Canada deems necessary to further consult with specific stakeholders during the project, the process will be undertaken by Parks Canada. In such case, the participation of the consultant will be limited to assisting Parks Canada in preparing relevant material (as determined during project realization and in accordance with the scope of the work) as well as integrating the outcomes to the project.
