Solicitation Amendment No. 003 is issued to answer a question from the industry.

Question and Answer

Question # 1: In the accommodations section of the tender, it is noted that the other guests must not be housed in the same area as Canada's personnel. If it is not 100% guaranteed that this is possible not to have to place someone else in a room on the same floor or hallway, does this therefore make the bidder non-compliant?

Answer # 1: That is correct. Due to safety concerns, other guests must not be housed in the same area as Canada's personnel. It is a firm requirement and if a bid cannot demonstrate this, then the bidder will be deemed non-compliant.

ALL OTHER TERMS AND CONDITIONS OF THE BID SOLICITATION REMAIN UNCHANGED
