2.6 Mandatory Site Visit

It is mandatory that the Bidder or a representative of the Bidder visit the work site. Arrangements have been made for the site visit to be held at 140 O'Connor St. Ottawa, Ontario on **June 20, 2019**. The site visit will begin at 10:00 EST, in Esplanade Laurier East Lobby.

Personnel security screening is required prior to gaining authorized access to *PROTECTED information, assets, or sites*. Bidders must communicate with the Contracting Authority no later than **June 18, 2019, 14:00 EST** to confirm attendance and provide the name(s) of the person(s) who will attend. The Bidder's Company Security Officer (CSO) must ensure that their representatives hold a valid security clearance at the required level for the site visit. Failure to comply with the security requirements will result in the representative(s) being denied access to the site.

Bidders will be required to sign an attendance sheet. Bidders should confirm in their bid that they have attended the site visit. Bidders who do not attend the mandatory site visit or do not send a representative will not be given an alternative appointment and their bid will be declared non-responsive. Any clarifications or changes to the bid solicitation resulting from the site visit will be included as an amendment to the bid solicitation.

It is mandatory that bidders provide and wear safety boots. Bidders who do not comply will not be permitted to attend the site visit.

Note: Bidders who attended the first Mandatory Site Visit that was held at 140 O'Connor St. Ottawa, Ontario on December 14, 2018 are not required to attend this site visit.
