Amendment 006 is raised to address Bidders questions:

Q012: Can we have detail on the transducer between frame 27-28? What would be the minimum height needed in case we have to remove it? Do you have other special appendices under the hull unless than sea chest grids and plugs that we see on the docking plan.

A012: There are two transducers located in the engine room transducer bay, in way of frame 27-28. The transducers are 50kHz LSE-134 units that are removed upwards/inwards of the ship. The bay is filled with a 50/50 glycol-water mix. There should be no special height requirements outside of the requirement already specified in the refit spec of a minimum of 1.5m. Other than the sea bay grid, anodes and plugs, there are no other equipment installations protruding from the hull that require special attention that would be in addendum to the requirements laid out in the docking plan.
